## RELATIVE TO COMMENDING THE HONORABLE LEROY F. GREENE

WHEREAS, The Honorable Leroy F. Greene, Assembly representative of the 6th Assembly District, will be closing his tenure of service at the end of this session, and, in recognition of the outstanding record of leadership and responsibility which he has displayed in office, is deserving of special honor and the highest commendations; and

WHEREAS, A native of New Jersey, Assemblyman Greene graduated from Purdue University in civil engineering, is licensed in that profession in several states, and founded Leroy F. Greene and Associates Consulting Engineers in 1951 in California; and

WHEREAS, A Democrat, he was first elected to the state legislature in 1962, and represents most of the City of Sacramento, Cal Expo, Rancho Cordova, and part of Carmichael; and

WHEREAS, Assemblyman Greene is best known for education legislation and legislation requiring the testing of all newborn children for PKU, a cause of mental retardation, and the Greene-Harmer Act which requires that new cars sold in California be manufactured to withstand impact at five miles per hour without damage; and

WHEREAS, The author of legislation correcting welfare abuses, Assemblyman Greene has also authored legislation on dating prescription drugs for effective use, consolidation of elections, absentee ballots, education of handicapped students, school finance, minimum standards for graduation, a statewide student testing program and legislation requesting prison inmates to transcribe Braille textbooks for blind students, establishing infant medical dispatch centers, legalizing bingo, and school construction for compliance with earthquake safety standards; and

WHEREAS, Assemblyman Greene is Chairman of the Committee on Education, a member of the Finance, Insurance and Commerce Committee and chairs its subcommittee on Unemployment and Disability Insurance, a member of the State Allocation Board and the Joint Legislative Audit Committee, and California's representative on the Education Commission of the States; and

WHEREAS, In addition, Assemblyman Greene has served on the faculties of the Engineering Extension of the University of California and Sacramento State University, is a Past President of the California Legislative Council of Professional Engineers, a Fellow of the American Society of Civil Engineers, and a member of the American Arbitration Association; and



RESOLVED, That the Chief Clerk of the Assembly transmit a suitably prepared copy of this resolution to the Honorable Leroy F. Greene.


